I want to thank all the residents who attended the City Council meeting on June 9th. Your participation in these meetings is vital to ensuring transparency and confidence in the democratic process. I would also like to thank Councilwoman Davis for serving as mayor pro tempore while I attended the American Medical Association's Annual Meeting of the House of Delegates in Chicago.

During the City Council meeting, two essential ordinances were passed. The first allows the city to collect taxes and offer a 50% early payment discount to residents who pay their 2025 property taxes on or before October 31, 2025. Mark your calendars now so that you do not miss this

opportunity. The second ordinance established the budget for the upcoming fiscal year, which begins on July 1st. Copies of the two Budget Ordinances are included in this newsletter.

People have told me that there have been postings on Nextdoor and Facebook about issues in our city. If you notice something in our city that needs attention, please contact the city office by phone or email. These social media platforms are great ways to build community spirit. Always remember that what you say and how you say it on Facebook reflects on our city. We all want to send the message that Windy Hills is a great place to live. The presence of the speed feedback signs on Ambridge and Indian Ridge has slowed the traffic on these streets. The question remains: has the impact been enough to allay the concerns of the residents who live along these corridors? Or, do we need to explore other measures, such as speed humps? ORDINANCE NO. 5 Series 2024-2025

CITY OF WINDY HILLS

ORDINANCE NO. 5 Series 2024/2025

AN ORDINANCE RELATING TO THE LEVY OF AD VALOREM TAXES FOR THE CITY PURPOSES FOR FISCAL YEAR ENDING JUNE 30, 2026

WHEREAS, by Ordinance No. 83, Series 1973, the City of Windy Hills elected to use the annual County assessment for properties situated in the City of Windy Hills, and

WHEREAS, there has been deposited with the City Clerk a complete list of all taxable property located within the City as of January 1, 2025.

BE IT ORDAINED BY THE CITY OF WINDY HILLS:

Section 1 The tax rate for the fiscal year ending June 30, 2025, is hereby levied, and fixed at the rate of \$0.170 per \$100.00 of property as assessed for taxation.

Section 2 The City Clerk shall make out and mail tax bills, sequentially numbered, from the assessment rolls as certified on or before October 1, 2025.

Section 3 The payment of tax bills shall be made to the City Treasurer and shall be subject to the discounts and penalties listed below and the collection remedies provided by law.

- A. A discount of 50% shall be allowed on tax bills paid during October 2025.
- B. The face amount of a tax bill shall be payable during November and December 2025.
- C. On tax bills paid after December 31, 2025, there shall be added thereto a penalty of 10% of the tax due plus interest from the date due at 1-1/2% per month or part thereof, compounded monthly, or \$10.00 if the penalty and interest are less than this amount, plus lien filing and release fees.
- D. All delinquent tax collection expenses incurred by the city, including lien filing and release fees, and collection/attorney's fees, shall be deemed a penalty in addition to that specified in Subsection "c" above and shall be encompassed within the City's lien.

Section 4 The proceeds of such taxes shall be used for the general operating expenses of the City, including the purchasing of City supplies, the erection of City signs, the general maintenance of public ways in the City, payment of bond premiums for City officials, sanitation, public safety and the payment of all the expenses incurred in the necessary and proper municipal functions as may be properly ordained or resolved by the City Council.

Section 5 The ordinance shall take effect and be in force from and after its passage and publication.

WHEREAS, the City Council has reviewed such budget proposal and made necessary modification, now therefore,

BE IT ORDAINED BY THE CITY OF WINDY HILLS

Section 1. The budget for the fiscal year beginning July 1, 2025 and ending June 30, 2026 is hereby adopted as follows:

Sojourn East Parking Lot Temporarily Closed

Sojourn East Church's parking lot will be closed to all vehicle and foot traffic from Wednesday, July 9, through Saturday, July 12, 2025, weather permitting.

During this time, contractors will repair cracks and apply a fresh asphalt seal coat. Once sealed, the surface will be re-striped. To ensure proper drying and curing of both the sealant and paint, no access to the lot will be allowed until the work is complete.

The church playground will remain open, but access will be limited to foot traffic across the south lawn from either Ambridge Drive or Rudy Lane. Sojourn East Church extends its thanks to the residents of Windy Hills for their patience and cooperation during this improvement project.

Parking Reminders for a Peaceful Neighborhood



To help keep Windy Hills streets safe and attractive, please keep the following parking guidelines in mind:

- No overnight street parking is allowed between 2:00 AM and 5:00 AM on any city street or cul-de-sac.
- All vehicles—including boats, campers, and trailers—must be parked on paved areas only. Parking on grass or unpaved surfaces is not allowed.
- Trailers, boats, and other occasional-use vehicles may not be stored in driveways or yards if they extend past the front of your home.
- Abandoned, inoperable, or unlicensed vehicles must be kept inside a garage—they cannot be left outside.
- Do not park facing the wrong direction on city streets at any time.
- For lots under 20,000 square feet, no more than four vehicles may be permanently parked in the open.
- Short-term exceptions can be made for holidays or guests.

Tree Alert: Scale Insects on Chinese Elms

Our Windy Hills arborist, Caroline Westfall, has recently discovered a scale infestation affecting several Chinese Elms on the Green. If you're not familiar with these trees, Chinese Elms—also known as Lace Bark Elms—are the ones with distinctive mottled bark and small, delicate leaves. They are a beautiful and common feature throughout our city.

Scale may be an insect, but it doesn't look like your typical garden pest. Instead of crawling or flying, scale appears as small, shell-like bumps, often found on the underside of leaves or along the branches and twigs. These insects feed by sucking the sap from the tree, which can lead to yellowing leaves, distorted growth, and if left untreated, a serious decline in the tree's health.

While treating scale on houseplants or small shrubs can be fairly straightforward, it's a much bigger challenge when it comes to mature trees. If you notice similar signs on trees in your own yard—particularly Chinese Elms—it's best to consult a certified arborist for proper diagnosis and treatment.

Keeping our trees healthy is vital to preserving the beauty and canopy of Windy Hills. Thank you for staying informed and doing your part!
