# 2016 Code Enforcement Update

Dear Residents:

In our continuing efforts to keep our city beautiful, and to be fair and consistent to all, please review the following items which will help us accomplish that goal in the upcoming year.

## Parking of Motor Vehicles/Boats/Trailers/Other Occasional Use Vehicles

- Overnight parking is not permitted on any city street or cul-de-sac between the hours of 2:00 AM and 5:00 AM. Because of recent safety considerations this Ordinance will be strictly enforced in 2016.
- No motor vehicle (everyday or occasionally) may be parked on any unpaved area.
- Trailers, Boats, Campers and other Occasional Use Vehicles may not be stored in driveways, where they extend beyond the front line of the home.
- Illegal parking – abandoned, inoperable, or unlicensed vehicles – are not allowed in the city, unless stored in a garage.
- Parking in the wrong direction on city streets is not permitted at any time.



## Signs

- Realtor signs are only allowed in the yard of the home for sale and must be placed behind the right of way (generally 12 feet back from street or home side of the sidewalk).
- Directional signs to the property are not allowed on any street. Our city does have city approved signs for this purpose. All signs must be removed day of closing. Please advise your realtor.
- Commercial advertising signs may not be placed at your property before the work begins and must be removed the day the work is complete.
- Personal event signs (Yard Sales/Auctions) are allowed on a limited basis. They may be placed no more than 24 hours before your event and must be removed immediately at event conclusion. Personal “Children at Play” signs do not conform to Kentucky law and are not permitted in the City.

## Garbage/Trash Pick-Up

- Garbage/Yard Waste may not be placed on the street prior to noon the day before the assigned date for the disposal.
- Cans and containers must be removed from the street before 7:00 pm on the day of collection. Tree trimmings and branches must be tied in bundles not over 4 feet in length. Other yard waste must be stored in cans or biodegradable paper bags. Plastic bags are no longer usable.

- Items too heavy or cans filled beyond the capacity of our contractor to lift on the truck will not be taken. Please be mindful of unusually heavy items, which may require special pick up arrangements. Please call 1-866-237-7019 ask for account #169216991 if you have questionable items. (These items may require an extra charge.)

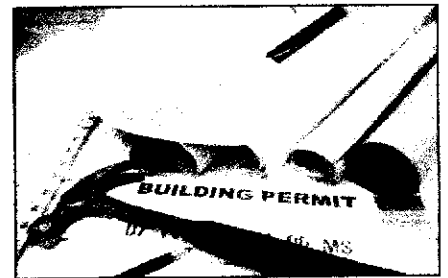
## Building/Remodel/Home Maintenance

- Windy Hills complies with Building Code Permit requirements of Louisville Metro Government. If you are doing construction on your own, or by contractor, if a permit is required, please post in plain sight on your property, for inspection. Permits should be obtained before construction begins. Questions call Metro Governments/Construction Review 502-574-3321.
- Dumpsters/Storage Pods should be placed to the rear of property where possible and may not be on site longer than 30 days without special Metro permit.
- Unused building materials/building waste/and appliances should be stored in the rear of property and must be removed promptly when construction is complete. Used or waste building materials will not be picked up by our contractor.
- Grass may not be allowed to grow higher than 7 inches. For the beauty of our city and your neighbors, we ask that you be mindful to timely, proper maintenance of bushes, shrubs, and trees on your property

## What Work On Your Home Needs A Building Permit?



If there is construction being done on your property, some requires a permit. Replacement and/or major alterations to plumbing, heating, electrical systems and the removal of any load bearing walls require building permits issued by Metro Government, even if the work is done by the homeowner. Repairs and general maintenance to these systems do not require permits. Additionally, the law requires that these permits be posted in plain sight on the property for inspection.

WHEREAS, a Budget Proposal and Message have been prepared and delivered to the City Council, and



**ORDINANCE NO. 4, SERIES 2016/2017**

**AN ORDINANCE GRANTING A COMMUNICATIONS  
FRANCHISE AND AUTHORIZING EXECUTION OF A  
UNIFORM FRANCHISE AGREEMENT**

**WHEREAS**, the City desires to award a non-exclusive franchise to Google Fiber Kentucky, LLC; and

**WHEREAS**, pursuant to Chapter 116.70 - 116.99 of the Metro Code of Ordinances, Sections 163 and 164 of the Kentucky Constitution, Louisville Metro solicited bid proposals from parties interested in obtaining franchises to erect, install and maintain communications facilities or provide communication services by use of said communication facilities within the confines of Jefferson County; and

**WHEREAS**, Provider submitted a bid proposal to Metro for a communications services franchise pursuant to the requirements of Chapter 116.70 - 116.99 of the Louisville Metro Code of Ordinances.

**NOW THEREFORE, BE IT ORDAINED AS FOLLOWS:**

Section 1. The City hereby grants to Provider for a period of twenty (20) years, a non-exclusive franchise to erect, install or maintain communications facilities or provide communication services by use of said communication facilities within the boundaries of the City in conformance with and subject to the terms and conditions of the Uniform Franchise Agreement attached hereto as Exhibit A and incorporated herein by reference as if set forth in full.

Section 2. The Mayor is hereby authorized to execute Exhibit A hereto, and may accept minor changes to Exhibit A provided that such changes and/or modifications do not materially alter the substance of the Agreement or any term thereof.

Section 4. Effective Date. This Ordinance shall be effective upon passage.

AN ORDINANCE AMENDING SECTION 3.c. & 5.c. OF THE CITY  
ORDINANCE REGARDING TREES**

WHEREAS, the city wishes to change the frequency of the tree board meetings, and

WHEREAS, the city is changing its method of tree planting contributions;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF WINDY HILLS, KENTUCKY:

Section            Section 3.c. is hereby amended to read as follows:

1.

Operation The tree board shall choose its officers and make its own rules and regulations. It shall meet monthly [at least once annually and when necessary.] and keep a record of its proceedings. A majority of the five voting members shall be a quorum for the transaction of business. The Tree Board reports to the Mayor of the City Council.



Section 5.c. is hereby amended to read as follows:

City Tree Planting Program

The City will contribute \$100 per [canopy] tree towards the planting of up to two (2) new trees per property, provided that the following conditions are met. [Trees must reach at least 30 feet height at maturity. The trees must be purchased from and planted by designated nurseries with which the City has agreements. The homeowner will pay the nursery for the tree at a 20% discount and the cost of its planting by the nursery. Upon the planting, the nursery will submit the paid invoice to the City. The City will send the homeowner a \$100 rebate per tree.]

Section 3            This ordinance shall be effective upon adoption and publication as required by law. First Reading held May 9, 2016. Second Reading, passed and approved June 13, 2016

**ORDINANCE NO. 1 Series 2016/2017**

**AN ORDINANCE RELATING TO THE LEVY OF AD VALOREM  
TAXES FOR THE CITY PURPOSES  
FOR FISCAL YEAR ENDING JUNE 30, 2017**

WHEREAS, by Ordinance No. 83, Series 1973, the City of Windy Hills elected to use the annual County assessment for properties situated in the City of Windy Hills, and

WHEREAS, there has been deposited with the City Clerk a complete list of all taxable property located within the City as of January 1, 2016.

**BE IT ORDAINED BY THE CITY OF WINDY HILLS:**

Section 1 The tax rate for the fiscal year ending June 30, 2017, is hereby levied and fixed at the rate of \$0.170 per \$100.00 of property as assessed for taxation.

Section 2 The City Clerk shall make out and mail tax bills, sequentially numbered, from the assessment rolls as certified on or before October 1, 2016.


Section 3 The payment of tax bills shall be made to the City Treasurer and shall be subject to the discounts and penalties listed below and the collection remedies provided by law.

- A. A discount of 40% shall be allowed on tax bills paid during October, 2016.
- B. The face amount of a tax bill shall be payable during November and December, 2016.
- C. On tax bills paid after December 31, 2016, there shall be added thereto a penalty of 10% of the tax due plus interest from the date due at 1-1/2% per month or part thereof, compounded monthly, or \$10.00 if the penalty and interest are less than this amount, plus lien filing and release fees.
- D. All delinquent tax collection expenses incurred by the city, including lien filing and release fees, and collection/attorney's fees of \$150, shall be deemed a penalty in addition to that specified in Subsection "c" above and shall be encompassed within the City's lien.

Section 4 The proceeds of such taxes shall be used for the general operating expenses of the City, including the purchasing of City supplies, the erection of City signs, the general maintenance of public ways in the City, payment of bond premiums for City officials, sanitation, public safety and the payment of all the expenses incurred in the necessary and proper municipal functions as may be properly ordained or resolved by the City Council.

Section 5 The ordinance shall take effect and be in force from and after its passage and publication.

## Arbor Day

Windy Hills was blessed with good weather for this year's Arbor Day Sunday, April 17. Our city arborist, **Caroline Westfield**, demonstrated the why and how of pruning. She showed homeowners how they could prune some of their plants and advised them to hire a certified arborist for the big jobs. Eleven White Swamp Oaks were won in a lottery. The winners were **Patti Del Grande, David Ellerbusch, Terese Fister, Maureen Friedman, Chris Gregoire, Dan Harmon, Nancye Johnson, Chloe Lawson, Terri Seltz, and Vicky Wieland.** **Donna Bondehagen** won a set of pruners. The trees will be delivered this fall, the optimum time to plant them. The White Swamp Oak is good because it can tolerate both wet and dry conditions. Kuddos go to Tree Board member **Cathy Thompson** for all of her hard work in coordinating the event.



## Coexisting With Deer

Many Windy Hills citizens are faced with the problem of the white-tailed deer causing damage to their yards. Not only do they eat your prize hosta and tear branches off shrubs and trees, the males can kill young trees when they "rut" their antlers to mark their territory. Because people have invaded their territory with new development, they have adapted extremely well to suburbia. In the early 1900's there were approximately 500,000 deer nationwide. Today there are over 15 million. Fawns are born in early summer. Bucks begin to develop antlers in early April. Growing antlers are covered with a skin called "velvet." Once the antlers stop growing, the velvet dries up. In Autumn, the males may use your Japanese maple to polish the velvet. They will shed the antlers in preparation to grow a new set.

A deer will consume 3% of its body weight each day. Thus a 250 pound buck needs 10 pounds of food daily. There seems to be a relationship between the value of the vegetation and its desirability. One can tell the difference between rabbit damage and deer consumption. Rabbits clean-cut plants. If the damage is ragged or ripped or is fairly high, it's probably a deer.

The question is how can people prevent or, at least, discourage Bambi? Short of erecting a 10 foot fence (disallowed by Metro) or an electric one, repellants are the primary solution. They fall under two categories: those

that taste bad or those that "stink." Hinder and Deer-Off are the only ones approved for edible plants. Apparently odor-based products work better than taste products. Apply them at the first sign of damage when no rain is expected for 24 hours and the temperature is between 40-80 degrees. Apply every 5 weeks or sooner. Home remedies include constructing an invisible fence of fishing line, drilling a hole in Irish Spring soap and suspending it from a tree, applying bob cat urine, filling a mesh bag of human hair (see a barber), or concocting a rotten egg solution. Barking dogs and motion detector lights may also help. Whatever you do, vary your method to keep them confused.

Plants rarely damaged include aromatic ones such as lavender, boxwood, ferns, hellebores, and American holly. Some that are seldom severely damaged include most dogwoods, european beech, hawthorn, forsythia, beauty berry, lilacs. However, a deer may break off a branch before he realizes he doesn't like it. And if a deer is desperate, he will eat almost anything. They seem to love redbuds, clematis, english ivy, fruit trees, yews, azaleas, rhododendrons, spiraea, viburnum, weigela, oaks (they adore acorns), and sugar maples, and most perennials and annuals.

To save saplings from rutting, encase them in early autumn using bamboo stakes and heavy twine. And when you are driving, watch out for deer at dusk and dawn. The automobile is their greatest predator.

# Opioid Addiction; A Medical Problem

With so many headlines and television specials currently discussing opioid problems none have addressed the specifics pertaining to our little corner of Jefferson County. Indeed the problem is here, just as it exists in every nook and cranny throughout the Metro area, State of Kentucky, and the entire United States. If you have questions, hopefully you will find some answers in the following few paragraphs. If not there are phone numbers and contact information in the list of treatment centers.

In addition to illegal heroin, the opioids themselves can be medical prescriptions obtained through your doctor from your local pharmacy, and the overdose may be accidental, or totally by mistake. According to Victoria Bond, Pharm D, RPh, the painkillers below are often prescribed:

Codeine	Fentanyl Patches	Norco (Hydrocodone)	Oxycodone	Vicodin (Hydrocodone)
Dilaudid	Methadone	Opana (Oxymorphone)	Percocet	

If you find a family member or friend unresponsive or breathing irregularly and you suspect heroin use because of past experience, or that they might have ingested too much of any of the above drugs, call 911 immediately. Ask for an ambulance and tell the dispatcher of your suspicions. The medical technicians will administer Narcan (Naloxone) which revives the victim almost immediately. The person then must be transported to an emergency room. The Narcan wears off in about an hour, and the overdose symptoms may return.

All ambulances carry Narcan, but it is not yet approved to be sold to individuals for private use. Although it is safe to use – even if no opiate was ingested – it must be administered by people trained to do so.

**Prevention & Aftercare:** Keep your prescription drugs away from children and all visitors to your home. Lock them up if necessary, but certainly keep them out of sight.

If you suspect a family member is using opioids, legal or illegal, try to get them to talk about it with a professional. In cases where the loved one is especially dangerous to him/herself, check the internet for Casey's Law. This offers a way to force the addict into life-saving treatment, and you will likely need your lawyer's help. This may seem a drastic and unpleasant undertaking, but considering the alternatives and the following numbers you may find it the most reasonable action to take.

"44% of Americans say they know someone who has been addicted to prescription painkillers, and 66% think the Federal Government isn't doing enough to combat painkiller abuse." – The Week Magazine; May 13, 2016

The Healing Place is a non-profit organization, and there are no fees or costs. It offers a detoxification program, and also is a long term residential facility manned by a very dedicated volunteer staff of peers, and is organized on the 12 step model. They proudly claim that 75% of alumni remain sober after a year. No referrals are necessary, but person must be 18 years and older, be screened and drug-free for the previous 48 hours.

**JADAC**, 601 - 605 South Preston, (502) 583-3951

JADAC (Jefferson County Alcohol and Drug Abuse Center), founded in 1975, is a non-profit, fee based, 80 bed inpatient and outpatient facility that accepts many forms of health insurance and third-party payers, including Medicaid. There are some sliding scale fees based on various factors. It offers a detoxification program, plus rehabilitation including counseling, life skills, recreation, relapse prevention, introduction to AA/NA and referrals to community services. Medical services are provided by licensed physicians and nurses. Referrals from health and social service providers as well as self-referrals are accepted. Patients must be 18 years or older.

**The Morton Center**, 1028 Barret Ave., (502) 451-1221

The Morton Center is a non-profit, fee based, outpatient facility that accepts pre-authorized private payer insurance, but does not accept Medicare or Medicaid. They offer various services, priced between \$90.00 and \$135.00. Counseling services are available for the entire family, plus young adults 12 to 18 years of age. They encourage individuals with questions to attend their "Concerned Persons" meeting held Tuesday evenings at 5:30 P.M. Just stop by or phone Diane at 451-1221, ext. 218.
